**Deductions:** Deduct \$380 per person for no air or ground transfers  
Deduct \$260 for no lift tickets (Non-Skier)  
\*\*\* Seniors 70 and over can purchase a 10 day senior lift pass for the same amount (\$260) as the 5 day lift pass.

**Payment Schedule:** \$250 Deposit July 7<sup>th</sup>.  
\$350 Due September 8<sup>th</sup> at our regular meeting  
\$350 Due October 6<sup>th</sup> at our regular meeting  
\$400 Balance due December 1st at our regular meeting

**Cancellation Policy:** All cancellations must be in writing to the trip leader -Sonny Smith  
The deposit of \$250 is non-refundable  
Cancellation after September 20<sup>th</sup> \$600 deposit is non refundable  
Cancellation after November 2<sup>nd</sup> 2010 is non refundable unless resold. You will be responsible to resell your spot, not the Club. If resold you will be responsible for paying a charge of \$175 name change fee. Resale must be made before January 1st, 2011 or the seller will be responsible for the purchase of a new ticket at the current fare rate.

**Trip Insurance:** Flights into mountain airports are often delayed or cancelled, which can incur additional cost to the traveler, for this reason the Club highly recommends that trip insurance for \$75 be purchased by the our trip members. Trip members opting not to purchase the trip insurance will be required to sign a waiver acknowledging their responsibility for any travel conditions delays or alternative transportation caused by poor weather conditions.
